

Minutes April 10, 2023

The Creswell Town Board of Commissioners met on Monday at 7:00 p.m. with the following members present: Mayor Edwin Ray Blount, Commissioner/Mayor Pro Tem Ronald Ambrose, Commissioner Brenda Logan and Commissioner Syble Spruill. Commissioner Joel Harris was not present for the meeting.

Commissioner Ambrose provided the invocation.

Commissioner Spruill led the Pledge of Allegiance.

Commissioner Spruill moved to approve the minutes and waive the reading of the March meeting(s). Commissioner Logan seconded the motion and it carried unanimously.

The finance summary was presented to the board by the clerk and accepted. Commissioner Spruill moved to accept the proposed budget amendment presented by the clerk. Commissioner Ambrose seconded the motion and it carried unanimously.

Unfinished Business:

-Commissioner Logan asked the status on the benches and Commissioner Harris was unavailable to give the status. The clerk informed the board that the benches were still sitting where they were delivered. The board agreed to have the maintenance guys install them.

New Business:

-The clerk mentioned to the board of several concerns of the parking lines on Main Street not being visible. The board agreed for the Mayor to reach out to the Department of Transportation about the lines and if DOT is unable to paint the lines then look into the town painting the lines.


-The clerk informed the board that the consulting company that is assigned to work with the town on the Resilient Coastal Communities Program reached out expecting to start work in a few weeks. Once underway, the first task together will be identifying appropriate staff and community members for a steering committee and gather any background information about coastal hazard issues in Creswell. The board discussed several names for the committee.

-The board set a budget workshop for Thursday, May 11th, 2023 at 9 a.m.

After no further discussion, the meeting was adjourned at 7:30 p.m.




