Minutes July 23, 2019

The Creswell Town Board of Commissioners met on Tuesday at 6:00 p.m. for a called meeting with the following members present: Mayor E. Ray Blount, Commissioner Brenda Logan, Commissioner Syble Spruill, Commissioner Ronald Ambrose and Commissioner Joel Harris.

The called meeting was to discuss a proposed draft to a new sewer contract with Tyrrell County Water and Sewer District #1 and Tyrrell County Water and Sewer District #2.

Micah Simonsen of Simonsen Law Firm was the only person present at the meeting.

Mr. Simonsen informed the Board that a copy of the proposed sewer contract had been sent to Tyrrell County and in return, Tyrrell County's attorney, Mr. Smith, sent back a proposed copy with some corrections.

The clerk needs to get Mt. Simonsen some data for information use.

The Board recessed until July 29, 20149 at 6 p.m. so that Mr. Simonsen can make some changes to the proposed agreement and talk with Tyrrell County.

Recess back on July 29, 2019

All board members were present except for Commissioner Harris and he was on phone conference.

Mr. Micah Simonsen informed that he had talked with Tyrrell County and presented to the Board a new updated agreement.

Mr. Simonsen needed to know the percentage of pipe running to the Tyrrell County line but no one had an answer.

The board recess until Thursday, August 1st, 2019 at 6 p.m. so he could get the answer.

Recess back on August 1, 2019

All board members were present.

Mr. Simonsen presented to the board a new updated sewer contract with Tyrrell County with all the changes.

Commissioner Spruill moved to accept the sewer contract with Tyrrell County Water and Sewer District #1 and Tyrrell County Water and Sewer District #2. Commissioner Ambrose seconded the motion and it carried unanimously.

After further discussion with the attorney, the board agreed to write-off the \$59, 542.80 Tyrrell County owed the Town of Creswell to illuminate anymore litigation cost.
