The town's deductible is higher than what the cost to repair the roof and FEMA reported that the town doesn't meet the minimum threshold for a small project so therefore the project was withdrawn.
- -The clerk presented to the board information on the NC Debt Setoff Program. She feels this program will help with collecting some uncollected water/sewer bills. The board asked the clerk if she would email them more information about the program to read over before the next meeting.
