Commissioner Logan provided the invocation.

The Mayor led the Pledge of Allegiance.

Commissioner Harris moved to approve the minutes and waive the reading of the May meeting(s). Commissioner Logan seconded the motion and it carried unanimously.

The finance summary was presented to the board by the clerk and accepted. Commissioner Logan moved to accept the proposed budget amendment presented by the clerk. Commissioner Harris seconded the motion and it carried unanimously.

No comments were made so the Mayor closed the public hearing and open the meeting.

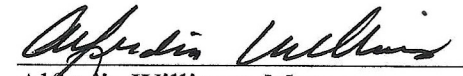

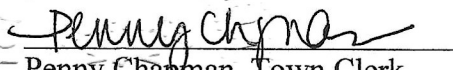
